### FIRST ELECTION TO SELECT A TOTAL RESIDENT BOARD OF DIRECTORS

As residents of Williamsburg Settlement, we are entering a new phase in the development of our community. The affairs of the Williamsburg Settlement Maintenance Association (WSMA) since its incorporation in 1977 have been directed by the Williamsburg Development Corporation (WDC). This arrangement has not always been satisfactory to the residents. Texas Management Corporation (TMC) has been managing WDC interests in the Settlement during the last couple of years. TMC has demonstrated its responsiveness and interest in the will of the residents through the inclusion of resident Directors during the last two years on the Board of Directors.

WDC's direct involvement has declined in the Settlement (approximately 6-7% of lot ownership), which has prompted TMC to relinquish direct control of WSMA and vest membership rights in the lot owners. The conversion of this responsibility will turn our community into a self-directed entity.

The control of our own affairs should not be taken lightly. Each resident should accept a reasonable share of the responsibility that will accompany our newborn freedom.

The first step in the conversion process to community selfmanagement will begin on September 21, 1985, when an election will be held to elect seven members to the Board of Directors of the WSMA. Many of your fellow neighbors have volunteered to serve the community in a direct capacity as Director. Each one has demonstrated how important the transition to resident control is to them by offering a most precious gift - their time.

Each resident should approach the election with a great deal of thought and awareness to select the best possible slate of Directors. The initial resident Directors will coordinate the affairs of the community for the next one and one half to three years.

The WSMA operates in the same manner as any corporation with a quarter of a million dollar budget. The Board of Directors will elect officers, approve expenditures, set annual maintenance fees, determine policy for swimming pool and tennis courts, approve architectural changes and enforce deed restrictions. Each resident should read the attached resumes carefully to insure that the new Board will have people with the proper skills to manage the association effectively. The operation of WSMA will be business-like and professional with written operating procedures and regulations. Each Board member holds a fiduciary obligation to all the residents of the Settlement to operate in an ethical and responsible manner and will be expected to adhere to a published Code of Ethics.

Many committees will be formed with specifically defined objectives to minimize the amount of time each individual committee member has to devote to Association activities. In order to adequately staff these committees, sign-up sheets will be available on election day for residents to volunteer their services. In conclusion, the management of the Association by residents does not end with a single casting of votes. Each individual must be willing to donate some of their time to make the transaction and the eventual day-to-day operation of the association not overly burdensome on the new Directors and their families. Additionally, I would urge every resident who is currently delinquent in their maintenance fees to reassess their situations to see if they can work with the current board to make arrangements to become current and be able to take an active part in the operation and development of our community.

A suggestion box will be available at the election pole. You are encouraged to make your suggestions to the Board so that we may evaluate how you would like to see community monies spent.

A majority of Joe's jobs were the management of engineering design and construction of base facilities and five years were spent as a Base Engineer responsible for operation and maintenance of Air Bases. Joe is a registered professional engineer and is an active member of his church and is a member of the Parish Council.
- 11. Lloyd Racicot. Lloyd has been a resident of Williamsburg Settlement for seven years As the incumbent resident Director of WSMA, he feels the transition to resident control is a very important matter and that the development of a proficient and professional organization to direct the Maintenance Association is of paramount importance to all residents of the Settlement. During his career as an engineer, business analyst and marketing manager, he has developed the organizational skills needed to effectively and professionally participate in the transition to total resident control of the Maintenance Association. During the last year, he has become very active in the management of the Association in the following capacities, Member of Con Committee on Pool Acquisition by by Maintenance Association, Resident Director of Maintenance Association, Member of Architectural Control Committee, and Organizer and Chairman of Committee to plan the Transition to Resident Control of WSMA. As the organizer and chairman of the Transition Committee, I have worked closely with Texas Management, Planned Community Management, and many concerned residents and potential Directors of the community. Through these relationships and his activities in the Maintenance Association as a Director, he feels that he can bring a degree of continuity to the transition process. He would very much appreciate your vote and support in the long and difficult process that is before us.
- 12. Robert D. Sease, Jr. Wife Cynthia, children Krista 11, and Leslie 9. Robert has lived in Williamsburg Settlement for eighteen months and is seeking election to the Board of Directors of the Williamsburg Settlement Maintenance Associaiton. He holds a Bachelor of Science Degree in Mechanical Engineering, has ten years experience in Project Engineering. He is a Registered Professional Engineer in two states. He has been employed by Marathon Oil Company for thirteen years, and is currently Manager of Corporate Purchasing.
