

WSMA-Swim Team Agreement

This Agreement is entered into on October 21, 2025, between:

Williamsburg Settlement Maintenance Association (WSMA) and the Williamsburg Settlement Swim Team.

1. Purpose

The purpose of this Agreement is to confirm the relationship between WSMA and the Swim Team and to establish expectations for shared use of the swimming facility.

2. Facility Use

- The Swim Team shall have scheduled use of the pool during designated practice and meet times as approved by WSMA.
- WSMA retains authority over the pool facility at all times and may modify use in cases of safety, maintenance, or emergencies.

3. Responsibilities of the Swim Team

- Provide WSMA and the Pool Management Contractor with the swim team's practice and meet schedule prior to the start of the season.
- Ensure that all Swim Team participants, coaches, and volunteers comply with posted pool rules, safety regulations, and any lifeguard or Pool Management Contractor directions.
- Provide adequate adult supervision at all Swim Team practices and meets.
- At the end of Swim Team practices and events, remove all trash from the pool area, leave the restrooms clean, and when the Pool Management Contractor is not on site, leave the facility properly secured.
- Provide liability insurance coverage and hold and defend WSMA harmless for any potential accidents or incidents that may occur during practices and events, and provide current Certificates of Insurance to WSMA prior to the start of practices each season. The Certificate of Insurance should evidence WSMA as an additional insured, include a Waiver of Subrogation in favor of the WSMA and include Primary and Non-contributory additional insured extension.
- Adhere to the provisions of the WSMA Policy Allowing Pool Use by Non-Resident Swim Team Members.

4. Responsibilities of WSMA

- Maintain the pool facility in good working condition for scheduled Swim Team use.
- Communicate promptly to the Swim Team regarding any closures or maintenance that may impact practice or meet schedules.

5. Relationship with Pool Management Contractor

 The Swim Team acknowledges that the Pool Management Contractor operates the pool on behalf of WSMA and will follow all reasonable directions given by the Contractor's staff.

6. Term

This Agreement is valid beginning with the 2026 swim season and will remain in effect until modified by mutual agreement of both parties, or revoked by either.
